Civil infractions are handled through the Clerk of Court. Those that do not pay fines are deferred to civil judgement. This typically results in a collection agency and an impact to their credit score. We are on the verge of implementing a compliance citation program whereby people who remedy violations like licensing and vaccination pay a fee to the department and the citation is not turned in.

The 7th Judicial Circuit of the State Attorney's Office handles the prosecution of these cases. Appeals are heard in front of a circuit judge at monthly court hearings. These hearing are generally referred to as Municipal Ordinance/County Ordinance Court

Those who don't pay or show up typically have credit issues, which means they don't see the deferral to civil judgement as a threat. The compliance citation program we are about to implement was very successful in my prior jurisdiction (Lee County Florida).

We have a fine schedule that is followed in the majority of cases. We can require a mandatory court appearance if the violation is egregious in nature.

Sec. 92.99. - Penalty.

Citation and penalties for chapter violations.

(1) An officer who has probable cause to believe that a person has committed an act in violation of this chapter may issue such person a citation. Any person so cited shall be deemed to be charged with a non-criminal infraction and cited to appear in county court. Such person shall sign and accept a citation indicating a promise to appear. (2) Any person who willfully refuses to sign and accept a citation issued by an officer shall be a violation of this chapter and may be prosecuted in accordance with F.S. § 828.27(5). (3) Any person cited for violation of this chapter may: a. Pay the civil penalty within thirty (30) days of the date of receiving the citation; or b. Appear in county court to contest the citation. (4) If such person fails to pay the civil penalty within the time allowed, or fails to appear in court to contest the citation, he shall be deemed to have waived his right to contest the citation. In such case, judgment may be entered against the person for an amount up to the maximum civil penalty. (5) Any person violating any provision covered by this subsection (a) shall, upon conviction, be subject to a civil penalty not to exceed five hundred dollars (\$500.00). (6) Any person cited for a civil infraction by an officer for a violation of this chapter who elects not to contest the citation shall be subject to the following penalties: a. Any violation of this chapter, unless otherwise specified: 1. For a first offense: \$50.00. 2. For a second offense: \$100.00. 3. For a third & subsequent offense(s): \$200.00 and a mandatory court appearance. b. Any owner of a declared Aggressive Animal who violates any provision of Sec. 92.02 or Sec. 92.41 will be imposed a fine of five-hundred dollars (\$500.00). c. Any owner of a dog declared "Dangerous" who violates any provision of Sec. 92.02 or Sec. 92.41 or F.S. § 767 will be imposed a fine of five-hundred dollars (\$500.00). (7) Civil penalties imposed pursuant to this chapter shall be independent of, and in addition to, any impoundment fees arising under section 92.10. (8) In addition to any civil penalty imposed pursuant to this chapter there shall be imposed and collected a surcharge of five dollars (\$5.00). The proceeds from such surcharge shall be used to pay the costs of training for animal control officers. (9) Any person charged with a criminal violation of this chapter shall not be cited for a civil infraction, but shall be prosecuted in the county court according to law.

If they fail to appear and still have not paid, we can request the magistrate send a letter requiring appearance. If still no response, we are working with our county attorney's office on a process to get them into county court.

We are working to get a system in place where if the magistrate sends a letter requiring appearance and the person still does not, we can get them into county court before a judge. Not in place yet.

Q5 If a citation is appealed, who hears your appeals? Special Magistrate, Hearing Examiner, does it go through the Clerk of Courts for a hearing, or something else?

A judge at the courthouse

Q6 Does your agency handle your own citations collections or is it handled through another agency? If so, who handles it?

Clerk of Courts

Q7 What are the repercussions if a citation isn't paid? Is it effective?

Final Judgment... not effective, as over 50% of the citations filed with the Clerk of Courts remain unpaid and have essentially been ignored by the offender.

Collier County Domestic Animal Services

Q8 Does your agency take pet owners to court or require mandatory hearings, or does this only happen if an owner appeals a citation?

We do issue mandatory court for egregious violations and also for 4th offense citations.
