All our licenses are only valid if the rabies vaccination date is valid. Some of these colors/license numbers will be valid for 3 years, depending if the pet owner purchased a 3 year rabies and a 3 year license. So even if a 2018 gold license has a 3 year rabies and pet owner wanted a 3 year license, the same 2018 gold license would still be valid for 3 years .

We use our electronic web based licensing system (PEARL) that veterinarian offices and Pasco County Animal Services use to monitor all our pre-numbered licenses, pet/pet owner information, rabies vaccinations and expiration dates. These certificates are printed out for pet owners when they purchase a license. We currently have 90 veterinary offices and mobile vets selling our licenses in 4 counties for Pasco County. We normally collect all unsold licenses and deliver new color licenses at the same time for the new year.
