We would strongly advise against a pet limit and have worked with many counties across the country to revise code to remove that language. If the intended goal is to prevent 'hoarding', a pet limit will not help you achieve that. People can and should be allowed to care for as many pets as they can. In some instances that may be 10 pets whereas in others it may be 1.

Also, this is typically an ordinance that is never enforced and only used when other issues are going on. If you have a situation of cruelty, neglect or hoarding those on their own should be able to be resolved with your other ordinances. A pet limit only hurts responsible citizens.
