BASE CRITERIA for Small Agency of the Year award:

- 1. Must be a current Regular Member of FAPAA.
- 2. Must have 25 or fewer employees.
- 3. Must have an effective training program for animal protection personnel.
- 4. Must have an effective public education program.
- 5. Must be actively involved in its community.
- 6. Must have an effective working relationship with other related organizations, i.e., health department, police/sheriff's department, humane society, shelters, etc.
- 7. Must comply with F.S. 823.15 and have records readily available on request.
- 8. Must comply with F.S. 823.151 and demonstrate initiatives to increase direct return to owner in the field
- 9. Must be willing to submit to an onsite inspection by a FAPAA Board member.
